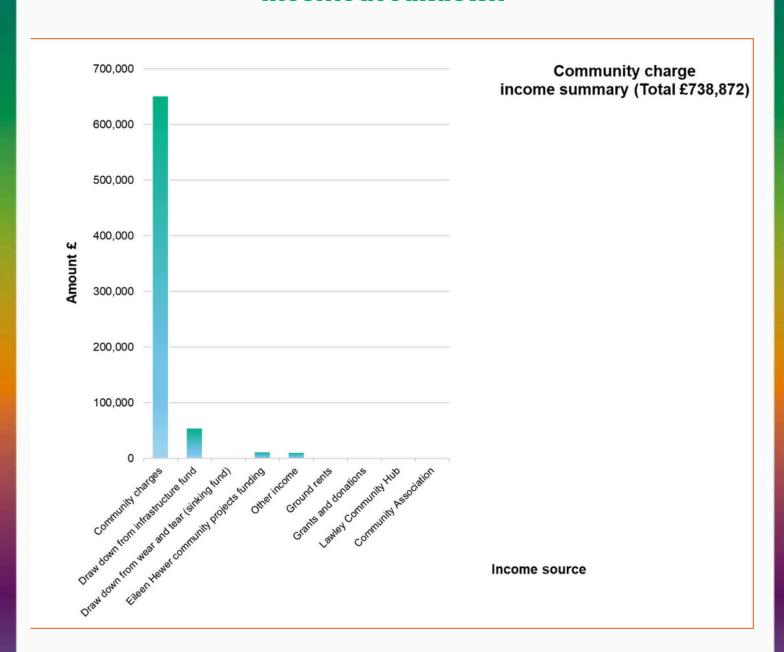

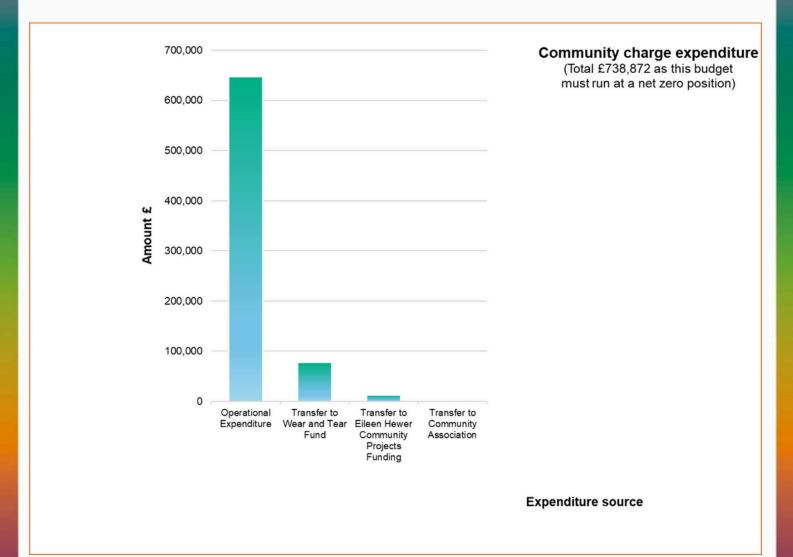








Expenditure breakdown





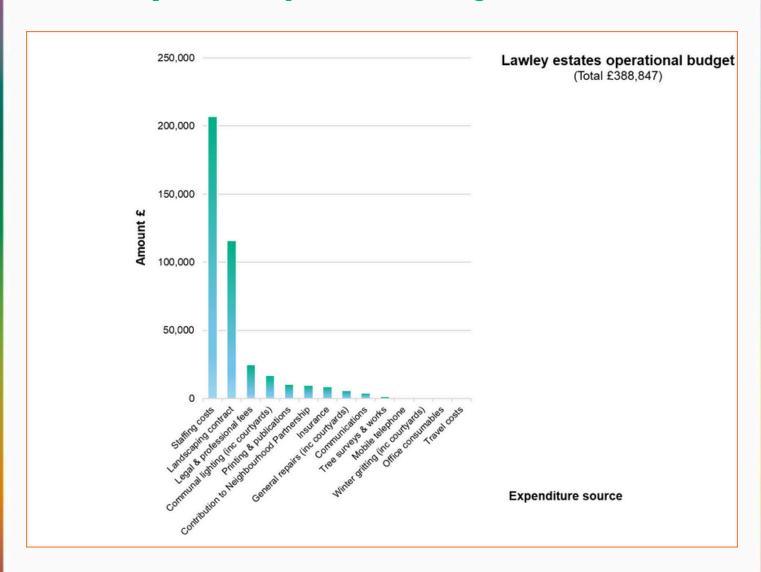








Lawley estates operational budget breakdown







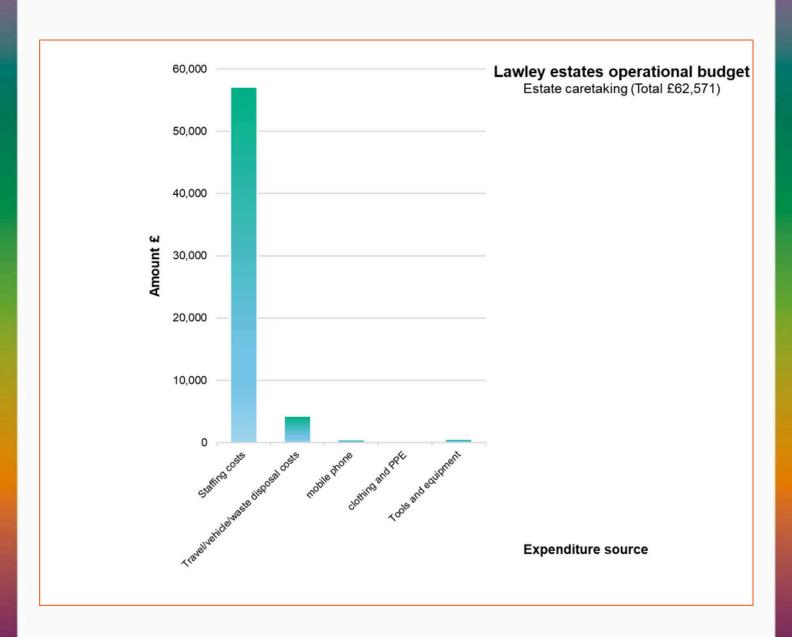








Lawley estate caretaking expenditure breakdown









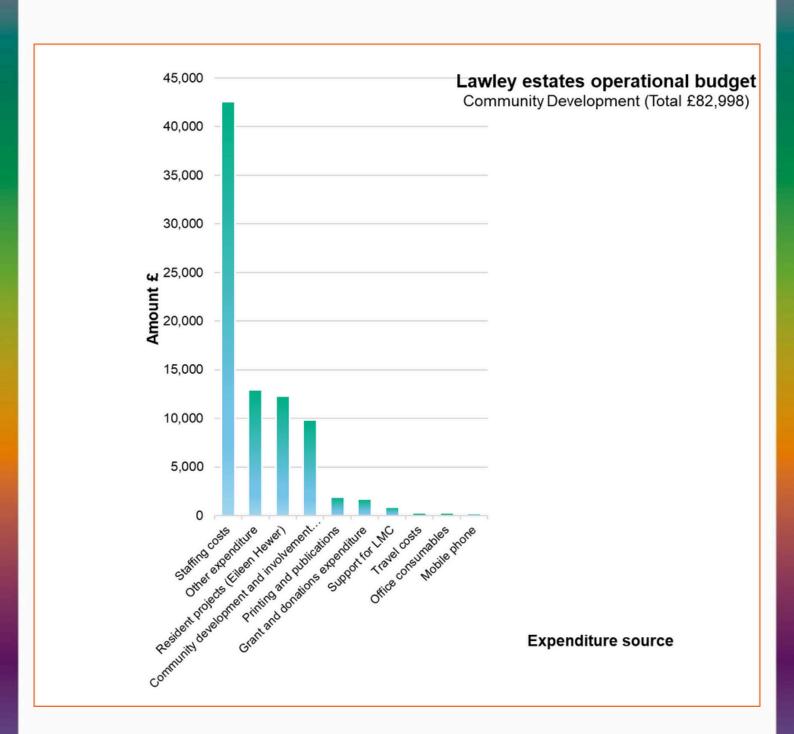








Lawley community development expenditure breakdown







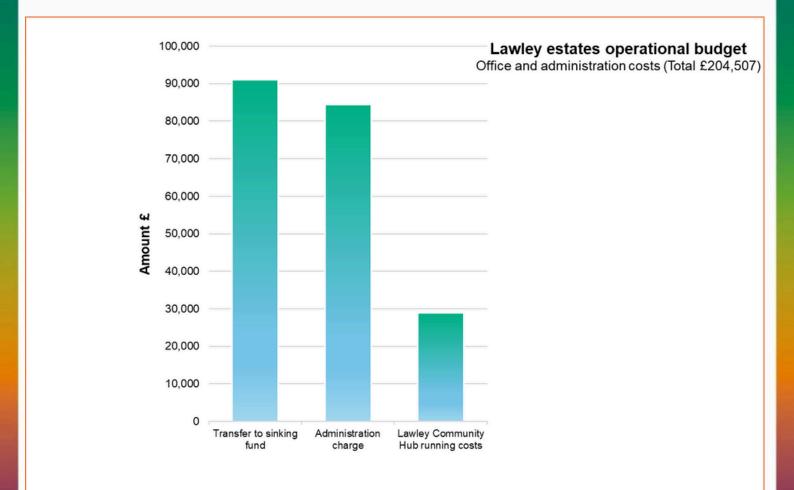








Lawley office running/administration costs expenditure breakdown
